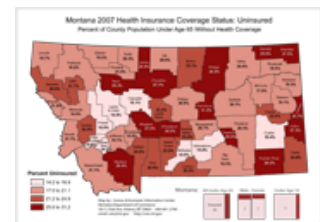

Small Area Health Insurance Estimates (SAHIE) for Counties and States

The Census Bureau's Small Area Health Insurance Estimates (SAHIE) program produces estimates of health insurance coverage for states and all counties. In July 2005, SAHIE released the first nation-wide set of county-level estimates on the number of people without health insurance coverage for all ages and those under 18 years old. In July 2010, SAHIE released 2007 estimates of health insurance coverage by age, sex, race, Hispanic origin, and income categories at the state-level and by age, sex, and income categories at the county-level.

New Products! The Census and Economic Information Center has historically compiled customized data charts for state and county estimates only. Now available on CEIC's website is a customized table showing a comparison of all states including rank. Also new to CEIC's map library is **Montana 2007 Health Insurance Coverage Status: Uninsured.**

New Webpage! Small Area Health Insurance Estimates are now located at www.ceic.mt.gov/sahie.asp. This new webpage also includes information about the SAHIE Program and a link to the Current Population Table creator. You can use the table creator to customize data you select.
